

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to the www.engageforward365.com and Engage Forward LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Engage Forward LLC include www.engageforward365.com and Engage Forward. By using the Engage Forward website, you consent to the data practices described in this statement.

Collection of your Personal Information

Engage Forward may collect personally identifiable information, such as your name. If you purchase Engage Forward's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction. Engage Forward may also collect anonymous demographic information, which is not unique to you, such as your age, gender, household income, political affiliation, race and religion. We may gather additional personal or non-personal information in the future.

Information about your computer hardware and software may be automatically collected by Engage Forward. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Engage Forward website.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Engage Forward's public message boards, this information may be collected and used by others.

Engage Forward encourages you to review the privacy statements of websites you choose to link to from Engage Forward so that you can understand how those websites collect, use and share your information. Engage Forward is not responsible for the privacy statements or other content on websites outside of the Engage Forward website.

Use of your Personal Information

Engage Forward collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Engage Forward may also use your personally identifiable information to inform you of other products or services available from Engage Forward and its affiliates. Engage Forward may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Engage Forward does not sell, rent or lease its customer lists to third parties.

Engage Forward may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide

these services to Engage Forward, and they are required to maintain the confidentiality of your information.

Engage Forward may keep track of the websites and pages our users visit within Engage Forward, in order to determine what Engage Forward services are the most popular. This data is used to deliver customized content and advertising within Engage Forward to customers whose behavior indicates that they are interested in a particular subject area.

Engage Forward will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Engage Forward or the site; (b) protect and defend the rights or property of Engage Forward; and, (c) act under exigent circumstances to protect the personal safety of users of Engage Forward, or the public.

Use of Cookies

The Engage Forward website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Engage Forward pages, or register with Engage Forward site or services, a cookie helps Engage Forward to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Engage Forward website, the information you previously provided can be retrieved, so you can easily use the Engage Forward features that you customized.
